# **SBES RETHINKS THE DATES**

Following the announcement by Point Promotions that the dates for SBES2008 would include a Saturday opening, research amongst visitors and exhibitors indicated a preference to the usual midweek opening therefore SBES is to move back to its usual Wednesday/Thursday slot.

"We originally changed the dates of the SBES to Friday and Saturday to attract more visitors, allowing weekend access to the show for audio professionals and enthusiastic volunteers when they weren't working" commented David McVittie, Organiser of the SBES.

"However, the feedback that we've received from visitors has indicated that holding the exhibition on a Friday and Saturday although interesting, was not proving as popular as the initial research indicated. So, we've decided to move the SBES back to its usual Wednesday/Thursday slot."

He continued "Our intention was to make some changes to SBES to benefit both visitors and exhibitors. Indeed we still are making changes, trying to ensure that SBES keeps up with the industry it serves. The new dates mean that there will be no clash with the BBC Children In Need appeal, which has previously kept some visitors away due to work commitments. So, the new dates have positive advantages for both exhibitors and visitors."

SBES2008 will be held on Wednesday 5 and Thursday 6 November 2008 at the NEC in Birmingham, UK.

# **Committee Report**

#### Congratulations

Congratulations to HBA's patron, John Whitney, on being appointed CBE in the New Year Honours list, for services to radio broadcasting and the arts.

#### **Appointments**

At its meeting on 17th November, the EC decided that it would not seek to fill the vacant Trustee position of Vice President. It was noted that, when he was in this role, the majority of Dave Nicholson's time was spent working on the National Hospital Radio Awards and on various other ad hoc responsibilities which he kindly took on. These responsibilities have now been taken on by a number of others, leaving little for a Vice President to do. As it is intended to re-structure the Association after the AGM in October, it was decided to leave the position unfilled, rather than create a new role description and attempt to fill the position, only for things to change again in less than a year.

To ensure that there is little chance of EC meetings being inquorate and to compensate for PR Manager Sean Dunderdale being unable to become a Trustee, Mike Skinner was appointed as a Trustee. The current set of Trustees are therefore:

  - Nigel Dallard (Winchester HR)
  - lain Lee (Scunthorpe HR)
- Dave Lockyer (Valley Park Radio, Dartford)
- Phil Moon (Radio DGH, Eastbourne)
- Mike Skinner (Mid Downs Radio, Haywards Heath)
  - June Snowden (York HR)

The full list of responsibilities for all EC positions, plus the list of ad-hoc responsibilities taken on by individuals in addition to those defined in their role descriptions, can be found on the website.

In addition, Dave Lockyer has recently appointed Elliot Kennedy, of Radio North Tees, Stockton-on-Tees, as the new North Regional Rep, replacing Tony Swinhoe, who stood down in October.

#### The Future of the Association

The number of responses received to the formal consultation paper 'The Future of the Association' was very disappointing. Only 13 stations (5.6% of the membership) responded. From these responses, the EC was able to identify few trends and there was little

concrete for the EC to take away from the consultation, other than that some of those who responded were unhappy, or unconvinced, by the EC's proposals to restructure the Association. Noting the near-unanimous vote at the AGM in favour of the principle, the EC has decided to proceed with its plans and more details should be available in time for the Spring conference.

Various comments made in response to the consultation regarding 'On Air' magazine are being reviewed; expect to start to see a few changes in the coming months. Likewise, comments regarding conferences and regional events have been taken on board; a proposal from a working group looking at this topic is scheduled for discussion at the January EC meeting.

The Association is here to support and represent member stations. It is, therefore, important that you tell the EC what you feel about what the HBA is doing today and what you think we should be doing tomorrow. Even though the formal consultation has finished, the EC is always interested in hearing your comments about what the HBA is doing – good or bad, just so long as they are constructive!

#### National Hospital Radio Awards and Spring Conference 2008

By the time you read this, the closing date for the 2008 National Hospital Radio Awards will have long since passed and the short list of nominees will shortly be announced. The Awards ceremony will take place at the

Queen's Hotel in Leeds on 29th March, during our Spring Conference. Details and a booking form can be found on the website. Good luck to all who have entered.

#### Charity Law update England and Wales

The government's Office of the Third Sector has published a revised implementation plan for the introduction of all aspects of the Charities Act 2006. New rules regarding the so-called 'solicitation statements' given when fundraising come into force in April. Also due to come into force around the same time are:

- changes to accounting and auditing requirements (these should not impact most hospital radio stations);
- the new definition of charity and the public benefit requirement;
  - the Charity Tribunal;
- various new powers for the Charity Commission;
- changes allowing Trustees of a charity, in certain circumstances, to be paid for work they do for a charity but not for being a Trustee; and
- changes making it easier for unincorporated charities to update their charitable purposes.

Some time during the summer, charities will be able to register as Charitable Incorporated Organisations and by so doing gain many of the benefits of incorporation (such as limited liability) without the need to be subject to Company Law.

The changes to the licensing of public charitable collections will not now come into force until 2009.

In the meantime, the Charity
Commission and the Office of the
Third Sector are consulting on further
changes to financial thresholds, with the
intent of further reducing the
administrative burden on small charities.
It's a question of just how far you can
go without damaging the charity 'brand'
by not keeping a sufficiently close eye
on what charities are doing, only for
malpractice (or worse) to come out
very publicly later.

#### Northern Ireland

The Northern Ireland Charities Bill started its progress through the Northern Ireland Assembly just before Christmas. Once passed, this will result in much more regulation of charities in Northern Ireland. Most of the Bill mirrors the Charities Act 2006 for England and Wales, but a few bits have been copied from Scotland.

The sixtieth anniversary of the NHS is being marked at this year's National Hospital Broadcasting Awards, with a medical theme to the ceremony.

Special guests on the night will include 'This Morning' Doctor Chris Steele and actress Lisa Kay, who plays nurse Carol Cassidy in ITV's 'Heartbeat'.

They'll be joined by the Shadow Secretary of State for Health, Andrew Lansley, CBE, MP.

Awards co-producer Sean Dunderdale told On Air, 'We're delighted they've agreed to attend the ceremony and help hand over the awards in, what is, a very special year for the National Health Service. Mr Lansley's attendance will also give the HBA the opportunity to highlight to a high ranking politician the good work carried out by the thousands of volunteers across the UK.'

As previously reported in On Air, Sean has taken on the mantle of coproducing this years event, while his Scunthorpe Hospital Radio colleague and now Deputy HBA Chief Executive lain Lee has organised the awards itself, which are now being judged on.

lain told On Air, 'We've had a tremendous response to the awards this year and I know the judges have a very difficult task in choosing a winner.'

Judges this year include Sunday Times Radio Reviewer, Paul Donovan; Editor at IRN, Jon Godel; Ofcom's Will Jackson and Jon Heasman, Lincs FM Group's Chief Executive Michael Betton; BBC Continuity Presenter, Duncan Newmarch; Heart 106.2's Paul Hayes; BBC Sport and BBC Look North presenter, Harry Gration; Labour's Vice-Chairman, former Hospital Radio presenter, Ian Cawsey MP; Malcolm Prince, Executive Producer at BBC Radio 2; Paul Easton, HBA Programming Adviser; Kirsty Ward, Editor BBC Swindon/Wiltshire; Pete Haslam, TV and Radio commercial voice over; Jeremy Buxton, BBC Radio York; Amandas Thomson,

BBC Radio Humberside; Richard Lyon, Station Manager, Compass FM; Keri Jones, Radio Scilly. The short-list of nominations will be published via the HBA-Announce e-mail system with the winners revealed at the ceremony in Leeds.

For the first time the Unsung Hero Award is being added, aiming to highlight the hard work carried out by volunteers behind the scenes of hospital radio stations across the UK.

The Special Award will also be included as a category this year, with nominations accepted for an individual, a team or an event that sums up all that's good and unique about Hospital Broadcasting.

Rookwood Sound's Sybil Fowler and Warwick Corporate Events are also providing technical support and staging for the ceremony, taking place at the prestigious Queens Hotel in Leeds on March 29th.

# **A Reflection on Newport**

It was seven o'clock in the morning, the sun was breaking over the Hampshire countryside and I should have been going to bed after a long night shift. Instead, I was sitting back on a train, with a can of beer in one hand and a suitcase in the other, not quite sure what I had let myself in for.

Thanks to the HBA's Conference Bursary, I was on my way to Newport to join delegates for three days of ... well something.

I am the first to admit that I was apprehensive about what I would come face to face with, being my first representation as the new Chairman of my station. But I must admit it was not what I thought it would be.

Friday turned out to be a chance to get acquainted and network with other stations.

My early arrival meant that I had a chance find out just how expensive the beer really was (prices mooted ranged from average to £5 a pint) and whether a trip into Newport town for more money was a realistic requirement.

After checking into the hotel, some of us were able to take a trip to Newport's local Hospital Radio station, Channel 1. We were welcomed by the station's Chairman which gave me a chance to see just how some of our associates around the country are doing things.

The visit was brief as dinner was rapidly approaching, as was the chance for some to jump into miniature cars for a quick meander around Newport Raceway. The rest of us decided on a few beers in the bar and a chance to take part in the traditional delegates' music quiz, reminding us that there are some rather disjointed releases out there!

Saturday was the day of learning. Morning seminars hosted by Paul Easton and the Charities Commission discussed how not to get caught out on air and then how to not get caught off air as well. Being directly involved in the running of a charity for the first time, it was a golden coincidence that I was effectively back in a school lesson, finally realising just how difficult my new role could eventually become.

For those of you that are looking at the NHS re-organisation, I would highly recommend talking to the Welsh office of the Charities Commission as they have already done their homework





and they took time out after the seminar to discuss individual cases.

The trade seminar was small but well attended. Between seminars the P-Squared, West Country Broadcasting and Sonifex stands were busy showing off their latest offerings. It is a shame that I can not justify buying a very large very wide-screen monitor to go with buying the latest in Myriad software, I wondered if they would notice it going missing ... and the Sonifex mixer ...

The Annual and Informal General Meetings were well attended in the afternoon with more local stations joining the day and residential delegates to discuss the new Executive Committee, the future of the HBA and the future of Patientline.

It gave an insight into exactly how the HBA was planning its own reorganisation as well as highlighting yet again the implications of the problems Patientline are having.

It was a chance for us to find out exactly how our associates in Hospital Radio stations across the country have to react and respond to localised issues within the business relations we have with them.

Cue a few hours break, a chance to refresh ourselves and prepare for an evening's entertainment from local male voice choirs, comedians and a visit from Little Britain's Andy and Lou! (okay, we all know they weren't the real Andy and Lou ... ooops. What do you mean you didn't) Rookwood Sound provided musical accompaniment into the small hours of the morning for those that could manage it, although many of us retired to the main hotel lounge for an alcohol induced reflection on the evening's proceedings.

Sunday morning was allowing for relaxation and a gentle easing back into society. Some chose to visit Rookwood Sound and others decided to visit the beautiful city of Cardiff. The coach and guide took us on a tour of the city and Cardiff Bay, allowing a few of us to take a trip into town for a little bit of shopping and for me, a visit to five years of my student life and a surprise visit on a few old haunts.

The weekend was not what I expected. The conference was more relaxed than I thought it would be and I was able to take a lot of information away as well as being able to meet with other station representatives as well as associates of the association.

The consensus appeared to be that numbers were falling for the Autumn event, which is disappointing and I felt that the opportunity was there for it to be a high quality and well attended event, as well as including the formalities of the AGM.


## **Phil Moon and the Stars**

# **National Award for Radio Tyneside**



Radio Tyneside has won a prestigious award for a carol service that was shared with a number of hospital radio stations across the country. The service was entered into the recent Christian Broadcasting Commissions annual awards where it was Highly Commended coming next to BBC Radio 4.

Station Director Dave Nicholson explains, 'Last year we decided to record a special Carol Service for broadcasting on Christmas Day. As I had recently moved to live in the country, I suggested we record the service at our local village Methodist Chapel.' Situated in Milbourne, a small farming community 15 miles north of Newcastle upon Tyne, the chapel attracts around 30 people to its weekly Sunday evening service.

When approached with the idea, the church committee agreed and suggested recording their annual carol service. Having seen the previous year's service, Dave said he didn't feel it was ideal for radio as it featured members of the youth group and was very visual. It was suggested that the Station record a special service and a Sunday evening was put aside for the recording. The recording took place on 10th December. It was felt we needed to record something slightly different from the usual carol service and decided to ask medical staff and local personalities to participate. At the same time it was suggested we offer the service to other hospital radio services across the country requesting that everyone broadcast it at the same time (10am) on Christmas Day morning, which then would unite patients across the UK who were unfortunately on a hospital ward that day. Fifteen stations agreed to broadcast the service. Two doctors and a local tv personality were asked if they would to do the readings along with some of the volunteer presenters from the station. They also approached a local Methodist lay preacher, Denis Carrs, to conduct the service. Denis had broadcast on previous occasions on Radio Tyneside and was aware of what would be required for a radio broadcast. Dave continues, 'On the day of the recording, we set up our equipment using only four microphones as the chapel only seated 80 people.


On arrival at the chapel on the evening of the recording, people were queuing up outside and one person was heard to say that in 40 years of attending the chapel it was the first time she had had to queue. Altogether 94 people where in the congregation, 14 standing at the back. We explained to the congregation what we were doing and asked them to feel that it was Christmas morning as we wanted to broadcast the service as if live, hence giving our listeners the feeling they were being linked together across the country.'

The service was recorded and despatched to those stations who had agreed to carry it, of which the feedback was so positive that Radio Tyneside decided to enter it in the CBC's annual religious awards. The service was huge success and a collection taken raised £418 for the Chapel.

## View from the Basement

#### Introducing Brett Ellis, our new columnist, with his unique view on life ...



Praise is the bedrock on which an individuals toils are quantified. National radio DJs have praise thrust upon them in the form of listener feedback, be it phone calls, texts or emails. Being a hospital radio presenter in search of praise and feedback can sometimes seem like you are a LIDL customer in search of foie gras. It exists but the chances of finding it are nigh on impossible.

As you sit reading this, the chances are you are in a basement room with no windows, alone or maybe with the next presenter milling about in the record library as you prepare to go on air.

I remember back in Hastings when I first started out at hospital radio (circa 1990), the excitement of presenting my own show for the first time. Although my intentions were to inform and entertain those who were suffering from illness, there were also selfish intentions in attendance too. I was going to blow the other DJs away, be funnier and more outlandish than any hospital or commercial DJ out there and have my humour recognised by those in the know. Within a year, I would be challenging Bruno Brookes as the prince of the airwaves and I would be the king of banter. I would be the chosen one that Anthea Turner pinned her future dreams on. All I needed was the praise from the listeners to keep my ego inflated and my talent unabated.

I recall receiving the studio key for the first time. I had never been in such a position of trust, nor had I been into the studio alone without assistance.

I should at this juncture, outline the geographical layout of the (now demolished) hospital radio station at St Helens Hospital. The entrance was through a back door which led into an underground tunnel which ran the length of the hospital. You turned right through the door which shut with a hearty thud and the only illumination was two murky emergency lights.

Opposite the studio entrance, which was about 100 yards down the tunnel, were the files of ex patients. Ex meaning deceased. Former listeners who now had no chance of hearing what I hoped to be a ground breaking foray into radio. I had previously, being the nosey sort, picked up a few files to see what they contained. The name and date of birth was clear, as was the word 'DECEASED' stamped in caps on the front of every single (and there were thousands) file. I never quite got to grips with the indignity of it all.

I, of course, was in full knowledge that the morgue was situated directly next to the studio. I had seen on various occasions eerie looking porters wheeling stretchers with body bags through the murk of the twilight zone tunnels to their

temporary resting place. I had, whilst training, moved quickly into the studio in order to avoid conversation with the porting death delivery drivers over the corpses.

Hastings, of course, is next to Bexhill, which has the unenviable claim of having the oldest average population per square mile in Europe. The body count was high and Hastings undertakers drive Porsches.

I arrived outside the studio to find one of the emergency lights flickering like I imagine Pete Doherty does when his dealer is on his annual holiday. As I fiddled around in my pocket for the key, I felt something cold brush against my arm, which left me feeling as welcome as Ann Summers at a Christian convention. I turned to face inevitable annihilation to be confronted with, not one but two, stretchers complete with body bags and contents. To say I fumbled to get the key in the lock as I attempted to hang onto my bladder is an understatement. My knees buckled and grazed against a door. I vaguely remember squealing to God, who I had been a firm believer in for all of four seconds.

I commenced radio history shivering, shaking and with the immortal line of 'Hello'. I had achieved stage one of my world airwave domination task. I had my own show imaginatively entitled.... 'The Brett Ellis phenomenon'  $\mathbb{C}^{\mathbb{T}}$ .

I kept the headphones off, listening for tap-tap-taps on the door and the phone to, or should I say 'in' hand. To state that my worries about the praise that was about to be heaped upon me had abated was a truth that was now a serious secondary concern. I was underwhelmed with the response to what was one of the weakest, most incompetent, inept and unhumorous shows in radio history. The listener(s), seemed to be behind me 20% and I played the opposite to a blinder (a sighter?).

With a valuable lesson learnt and my fragile ego not only murdered but hung, drawn and quartered, set alight and buried in concrete beneath a major tower block, I managed to persuade the next DJ, (Rob Rock), to walk me to the studio door as I continued chatting at ever increasing volume as I walked outside into the world and out of my personal hell.

I had never been so pleased to gently jog in the driving rain in December in Hastings as I had that day on my now near sprint to the car. As I fumbled in my pocket for the car keys, I remembered I had put them on the turntable in the main studio. It was a long, but wet and satisfying jog home.

# **Beware Bogus Callers**

#### Derby Hospital Radio work with Trading Standards

Hospital Radio in Derby, Radio Link has been working with the regional Trading Standards Departments of the East Midlands to produce a first for hospital radio and local government.

Last year a successful campaign of infomercials featuring Shaw Taylor, former presenter of a regional crime programme, was produced by Saga FM for Trading Standards East Midlands. During an informal networking discussion meeting, otherwise known as the Christmas Party, Mark Atherton of Radio Link spoke to Group Producer for Saga Radio, Ian Chilvers (ex-Derby Hospital Radio member) whereupon the idea came about of running the Saga produced infomercials on Hospital Radio in Derby.

The original arrangement was very informal but Mark quickly realised that the message could be used by all hospital stations in the East Midlands. Away from hospital radio, Mark Atherton is a Senior Trading Standards Officer with Derbyshire County Council and has involvement with delivering the message about bogus callers and doorstep crime.

The idea developed into working with Saga FM to obtain permission to supply the infomercials across the region and to waive any re-licensing charges. To support the infomercials, Mark interviewed Brian Steele, a former police officer with particular expertise in dealing with bogus callers. Mark produced a five minute interview to accompany the infomercials. A press pack was also supplied to hospital radio stations detailing their local Trading Standards office contacts and a template press release for stations to use for local press publicity.

In all, the project involved five County Councils, three Unitary City Councils, 15 hospital radio stations, a regional FM station and took input from the co-ordinating group tackling bogus callers.

For auditing and accountability purposes, East Midland Trading Standards Departments required a

response questionnaire completing relating to the material. As an incentive to complete the required return, Trading Standards sponsored the broadcast of the infomercials and interview to the tune of £150 for each participating hospital radio station for a six month period.

Whilst this was successful, it highlighted problems relating to copyright and funding as Saga would require payment for use on radio stations outside the charitable status enjoyed by hospital radio. Whilst Saga had been very helpful and willing to participate, there were inevitable delays whilst the administrative aspects of the project were resolved.

As a member of Derby Hospital Radio, Mark won for Radio Link two HBA gold awards for trailers and production, he produced a specialist music show entry that won gold and won a certificate of commendation, also for audio production. He suggested Trading Standards in the East Midlands commissioned their own infomercials which could be used on hospital radio, on the new tier of community radio stations and local commercial radio, without the need

to seek permission or incur further cost each time it was used.

Mark was part of a small team from Trading Standards who devised the content of the scripts and he sourced two professional voice-over artists to record the material which was edited at Derby Hospital Radio's studios. Mark also voiced part of the infomercial. For the use of their studio facilities to edit and master the infomercials, Derby Hospital Radio received a donation equal to the fee charged by one of the voice-over artists.

The audio has now been produced and is being sent to all the hospital radio stations in the East Midlands for use in 2008 to update the doorstep crime message. The infomercials will again be accompanied by a donation of £150 to each participating hospital radio station. Last year 13 stations were involved in the campaign ranging from Pilgrim Hospital Radio at Boston across to Castle Mead Radio in Leicestershire.

# Good Times for Radio Wishing Well



2007 was an exciting year for Radio Wishing Well at the Trafford General Hospital. In April, we celebrated our silver anniversary. We joined the 21st century with the purchase of Myriad and celebrated ten years in our current studio.

The idea of RWW was the brainchild of Byron Richards (X Ray department at TGH) in 1977, when he and Derek Welch (a manager at the hospital) started the bid to launch the station. As with most hospitals, space was a problem. An area was found when the hospitals telephone exchange was revamped and a smaller system installed. The only problem was that 'The Well' had no doorway. The space was only large enough for a studio and small office but it was enough to operate from.

With this and other obstacles resolved, the new station was almost ready in the middle of 1981. A competition was set by a local building society to find a name and give the station some much needed publicity and the winning name, Radio Wishing Well.

The first broadcast featured local radio presenter Dave Ward (Piccadilly Radio) and the first show was by Paul Fairclough (currently with Bradford's Pulse Classic Gold).

RWW spent its first 15 years in little more than a broom cupboard. By the mid 90s, under the managership of Jim Hardy, RWW had formed a strong bond with the hospital management which was instrumental with The Well being granted a larger space. The new studio (formerly a toxicology lab) boasts enough room for two studios, kitchen, cd store and spacious office space. RWW moved into its new studio in October 1997. In October 2007 the whole team, former members and Trust managers celebrated not only 25 years of The Well but also ten years in the new studio.

#### **HBA Grants**

The HBA Grants programme was introduced in 2006 following the Executive Committee's suggestion to PPL that a proportion of their donations to the Association in 2004 and 2005 be allocated for grants to member stations.

WHO IS ELIGIBLE? - Applications are restricted to Full Members of the HBA.

**THE PURPOSE** – The grants are intended to enable hospital broadcasting organisations to purchase equipment or other materials required by them which they are unable to afford to purchase from their own funds.

**HOW DO I APPLY?** – Applicants should identify the equipment or other materials that meet(s) their needs and should obtain a quotation (ideally more than one) for the supply. They should then complete the attached application form and it, together with copies of the quotation(s), their constitution (or other governing document) and their latest annual report & accounts, to Julie Cox, HBA Treasurer, 37 Alford Street, Grantham, Lincolnshire, NG31 8BX.

WHAT HAPPENS NEXT? – Applications will be acknowledged on receipt. The subcommittee will meet bi-monthly to consider applications. As soon as possible after consideration, applicants will be informed as to the success or otherwise of their application. Successful applicants should expect to receive a cheque within 28 days of their application being granted. Copies of invoices confirming purchase of the equipment/materials should be forwarded to HBA within 6 months of the grant cheque being issued. Failure to provide such evidence of purchase may result in full repayment of the grant being requested.

Applications are judged on merit by the HBA's Grants Subcommittee, which consists of Julie Cox, Sean Dunderdale, Dave Lockyer and Mike Skinner. If an conflict of interest arises between a member of the subcommittee and an application, the conflicted member will withdraw from discussions surrounding the particular application and, if necessary, further temporary members will be co-opted to the subcommittee. The full terms of reference of the subcommittee can be found on the members-only section of the HBA website, or are available on request.

ARE DETAILS OF SUCCESSFUL APPLICATIONS PUBLISHED? – HBA would like to maximise the publicity obtained, both local to the recipient of the grant and nationally, and would expect successful applicants to work closely with the HBA's Public Relations Manager to achieve this.

HBA would anticipate providing details of all grants made in its Annual Report and Accounts.

**PLEASE NOTE** – The decision of the Grants Subcommittee is final and no correspondence will be entered into. The subcommittee may, at its sole discretion, provide unsuccessful applicants with an indication as to why their application failed - for instance, applicants can expect to be informed if they failed to provide all necessary supporting paperwork, or their application was deemed ineligible in other ways. However, applicants should understand that the funds available are limited and not all applications that meet all the required criteria are likely to be funded.

### **Conference Bursary**

The HBA Conference Bursary was introduced in 1994 in memory of Brian Snowden, acknowledging his commitment to the Association and hospital radio. The bursary is now also dedicated to Ken Fulstow, George and Myra Burton, and Helen Hamilton, recognising their contributions to the Association.

WHO IS ELIGIBLE? – Applicants should be active volunteers within a Full Member of the HBA. The successful applicant usually has not previously attended a conference. We are unable to award bursaries to young persons under the age of 18 unless we receive written parental consent and an adult from the applicant's station is willing to accept responsibility for their welfare whilst attending conference.

**THE PURPOSE** – The bursary provides successful applicants with an opportunity to meet fellow hospital broadcasters, and to find out about the work of other stations and the HBA. HBA conferences provide a training opportunity through seminars and workshops, and enable delegates to network with fellow hospital broadcasters, providing insight into the wider aspects of hospital broadcasting and the national association.

Successful applicants are required to write a report on the conference for their station's management committee, with a copy provided to the HBA Treasurer within one month of the conference. The report should explain what the recipient learnt at conference, detail the best and least good things about the weekend, and suggest ideas that the station's management committee should consider implementing.

**WHAT DOES IT COVER?** – The bursary pays up to the residential costs for individual applicants to attend the full weekend conference. Applications for payment of travel costs will also be considered.

**HOW DO I APPLY?** – Applicants should complete Section 1 the attached form, and then obtain the endorsement of the Chairman (or another officer) of their station in Section 2. WHAT HAPPENS NEXT? – Applications are judged on merit by the HBA's Conference Bursary Subcommittee, which consists of June Snowden, Julie Cox and Nigel Dallard. The full terms of reference of the subcommittee can be found on the members-only section of the HBA website, or are available on request. Applicants will be informed of the success or otherwise of their application at least 8 weeks before the conference. 
